Subject: 2019 Key Dates and Registration Information for New Jersey Student Learning Assessment for Science (NJSLA-S)

This memo is being sent by Measurement Incorporated (MI) on behalf of the New Jersey Department of Education (NJDOE). This memo provides a reference sheet of key dates associated with the New Jersey Student Learning Assessment for Science (NJSLA-S) Spring 2019 Administration. The reference sheet is at the end of this memo. This memo also includes information regarding the Student Registration/Personal Needs Profile (SR/PNP) data upload process and scheduling for the NJSLA-S Spring 2019 administration. Additional information regarding testing times, blueprints and practice tests will follow.

Student Registration

For the Spring 2019 NJSLA-S, districts will upload their SR/PNP directly to Pearson Access^{next} (PAN) to register students for the assessment. 2019 is the first operational year of NJSLA-S and it is important to complete student registration during the timeframe provided below. We realize that there will be some registration changes due to new students, transferring students, etc., but during this window, it is important to have the most complete registration data possible.

Timeline for the SR/PNP process:

- November 29-30, 2018: The SR/PNP field definition guide and file upload template for the NJSLA-S will be available via PAN.
- December 3-18, 2018: The student data upload period. Districts must complete the initial SR/PNP upload between December 3, 2018 and December 18, 2018 for Science.

Districts must upload their Spring 2019 NJSLA-S SR/PNP files directly to PAN, **not** through NJ SMART.

Test administration

The NJSLA-S is a computer-based assessment, and most students should take the assessment on a computer. Students who are unable to use a computer, based on a need documented in a valid Section 504 Plan or Individualized Education Program (IEP), will take the assessment using paper and pencil. The NJDOE will review the SR/PNP uploads and may contact districts to verify the accuracy of the student counts and test delivery modes if anomalies are detected.

Students receiving homebound instruction are not required to take the NJSLA-S using paper-based versions of the assessments. Districts have the **option** of administering the computer-based assessment, using a district-supplied portable electronic device and mobile hotspot, to students receiving homebound instruction. The mode of testing should be based on individual student need and the content area/subject being assessed.

For detailed information regarding homebound test administration procedures, please refer to the <u>New</u> <u>Homebound PARCC Test Administration Procedures</u>, which is applicable to the NJSLA-S.

District test coordinators and technology coordinators must review the school staff that have access to PAN and determine if any modifications to the user accounts are needed. In addition, some user accounts may need to be deleted from PAN including accounts for staff that no longer work in the school or district, as well as staff members whose positions have changed and should no longer have access. As in past test administrations, users within PAN will receive email updates, so it is crucial to keep the user list up to date. Training Sessions

The NJDOE will conduct regional professional-development workshops and will provide regional training sessions for district test coordinators and technology coordinators. The regional district training sessions for the NJSLA-S will be incorporated with the NJSLA-ELA & NJSLA-M regional trainings.

Dates for the regional trainings are:

- Northern region: February 20-21
- Central region: February 25-27
- Southern region: February 28

The NJDOE will be providing districts information on how to register for the regional trainings in December.
